To request access to the MyChart record of an adult whose medical care you help manage, please complete this form. The patient must sign this form and provide authorization for release of medical information in MyChart on the 'Adult Proxy Authorization Form'. Please note that the patient's chart will be accessed through your (the proxy's) MyChart record. Completing this form will establish a MyChart record for you and for the patient.

MyChart Terms and Agreement

- I understand that MyChart is intended as a secure online source of confidential medical information. If I share my MyChart ID and password with another person, that person may be able to view my (or my child's) health information, and health information about someone who has authorized me as a MyChart proxy.
- I agree that it is my responsibility to select a confidential password, to maintain my password in a secure manner, and to change my password if I believe it may have been compromised in any way.
- I understand that MyChart contains selected, limited medical information from a patient's medical record and that MyChart does not reflect the complete contents of the medical record. I also understand that a paper copy of a patient's medical record may be requested from the patient's clinic.
- I understand that Although MyChart contains limited medical information, individuals with proxy access will have unrestricted access to diagnostic information which may be considered sensitive (i.e., HIV/AIDS, mental health, genetics, pregnancy).
- I understand that access to MyChart is provided by Northwestern Medicine as a convenience to its patients and that Northwestern Medicine has the right to deactivate access to MyChart at any time for any reason. I understand that use of MyChart is voluntary, and I am not required to use MyChart or to authorize a MyChart proxy.

Adult Proxy Authorization for Release of Medical Information

This form is an authorization that will permit Northwestern Medicine to release your medical information to your designated adult proxy. Please read it carefully.

I am requesting that _____ (insert name of proxy) receive access to my health information that is available in my Northwestern Medicine MyChart record. This person is my designated MyChart proxy. I authorize Northwestern Medicine to release the health information contained in my MyChart record to my MyChart proxy. I understand that the medical information in MyChart is obtained from my electronic medical record and may include information from all Northwestern Medicine facilities. I authorize release of any information contained in my MyChart (EMR) record held by Northwestern Medicine to my designated proxy.

I authorize release of this information only through my MyChart record. This form does not authorize release of my medical record to my designated proxy by other methods or in other forms.

I understand that once information has been disclosed, it potentially may be re-disclosed by the proxy and the disclosed information may not be covered by federal privacy protections.

Participation in MyChart and designating a MyChart proxy is completely voluntary. I understand that I am not required to designate a MyChart proxy and I am not required to provide this authorization. I also understand that Northwestern Medicine does not condition any of my health care treatment, payment or other services on whether I provide this authorization. However, I also understand that if I do not provide authorization, Northwestern Medicine is not permitted to provide access to my MyChart record to my designated proxy.

This authorization will expire automatically one year from the date of my signature. I also may revoke this authorization at any time by contacting the MyChart HelpDesk at 630.933.2255. For the hearing impaired TTY 630.933.4833. I understand that if I revoke this authorization, my designated proxy's access to my MyChart record will be ended. I also understand my revocation will not affect any disclosures that were made prior to processing the revocation request.
